NOTICE OF COMPLETION OF CONSULTATION AND DOCUMENTATION REPORT Public Work Class Environmental Assessment

Proposed Ontario Place Site Servicing Replacement and Upgrades

955 LAKESHORE BOULEVARD WEST, TORONTO

Jacobs, on behalf of the Ministry of Heritage, Sport, Tourism and Culture Industries (MHSTCI), has now completed the Consultation and Documentation (C&D) Report for the proposed site servicing and upgrades located at Ontario Place, 955 Lakeshore Boulevard West, Toronto.

As described in the C&D Report, MHSTCI is proposing to reconfigure and update the 50-year-old Ontario Place site services to meet current code by replacing, reconfiguring and/or upgrading the existing on-site underground utilities (water, wastewater, electrical, gas); provision of redundant/back-up off-site service connections to external infrastructure networks (City of Toronto, Toronto Hydro Enbridge Gas, Telecom service providers, etc.); and inclusion of stormwater management.

This undertaking has been assessed as a **Category B**, in accordance with the requirements of the Ministry of Infrastructure Public Work Class Environmental Assessment. Figure 1 provides a site location map.

This letter is to inform you that the C&D Report is available for review in the [Updates](#) section of the Engage Ontario Place website. Due to COVID precautions, there is no viewing available in person at this time.

Subject to comments received during the review period and the receipt of necessary approvals, the province intends to proceed with the proposed undertaking.

If no request is received by June 30 2022 (extended from May 26 2022) the proposed undertaking will proceed, as outlined in the C&D Report.

This Notice was re-issued on March 26, 2022 (initially issued on April 28 2022).

General Comments

Interested persons may provide written comments to our project team from April 28 2022 to June 30 2022. The Consultation and Documentation Report has been completed. Comments are typically collected over a 30-day period, but the comment period has been extended for this project. All comments and concerns should be sent to the proponent care of the undersigned for a response within this 60-calendar day comment period.

Requests to the Ministry of the Environment, Conservation and Parks

In addition, a request may be made to the Ministry of the Environment, Conservation and Parks (MECP) for an order requiring a higher level of study (i.e., requiring an individual/comprehensive Environmental Assessment approval before being able to proceed), or that conditions be imposed (e.g., require further studies), only on the grounds that the requested order may prevent, mitigate or remedy adverse impacts on constitutionally protected Aboriginal and treaty rights. Requests on other grounds will not be considered. Requests should be sent to the contacts below and include the requester's contact information and full name. A copy of the request should also be sent to the undersigned.

Requests should specify how it pertains to a constitutionally protected Aboriginal or treaty right, what kind of order is being requested (request for additional conditions or a request for an individual/comprehensive environmental assessment), how an order may prevent, mitigate or remedy those potential adverse impacts, and any information in support of the statements in the request. This will ensure that the MECP is able to efficiently begin reviewing the request.

Freedom of Information

The public record, including your personal information, will be available to the general public unless you request that your personal information remain confidential. It will also be analyzed, on an anonymized basis, to ensure that our consultations are reaching an inclusive and diverse audience.
